FIREFIGHTER TRAINING PROGRAM UNDERWAY

MVFD Firefighters are currently undergoing an intensive Probationary Firefighter training regimen aimed at achieving an Introductory Firefighter certification with the State Firemen's & Fire Marshals' Association (SFFMA), during a period of eight months. The condensed nature of this 78-hour program requires firefighters to commit to an average of 10 hours of classroom and hands-on training per month. The goal of the program is to obtain a baseline level of knowledge and proficiency for all current members and to serve as a prerequisite for future participation in extra-departmental training and achievement of more advanced levels of certification. In addition, the program is designed to provide all required non-live fire training internally so as to reduce the amount of money spent on extra-departmental training and travel.

The MVFD Probationary Firefighter Program meets or exceeds State standards and will cover the following topics of instruction:

- Fire Department Organization
- Forcible Entry
- Ladder Practices
- Fire Hose Practices
- Fire Streams
- Ventilation Practices
- Rescue Operations
- First Aid
- Fire Behavior (Fire Science)
- Safety and Protective Clothing
- Ground Cover (Wildland Firefighting)
- SCBA (Self-Contained Breathing Apparatus)

Students successfully completing the Probationary Firefighter Program will immediately enter the MVFD Basic Firefighter training program to achieve a 187-hour Basic Firefighter certification. The 78 hours of training already obtained will be applied toward this higher level of certification.

The lead instructor for both programs is one of our own: Assistant Fire Chief Douglas lannelli, an 18-year veteran of the fire service, currently a Lieutenant with the Austin Fire Department's Training Division. His certified training achievements include:

Advanced Firefighter; Fire Officer II; Fire Instructor II;
Pumping Apparatus – Driver/Operator; Hazardous
Materials Technician; SFFMA Advanced Firefighter
and Level II Instructor; and Texas Department of
Health EMT-Basic


MULDOON COMMUNITY PARK PAVILION CONSTRUCTION PROJECT

TEXAS FOREST SERVICE SUPPORT http://txforestservice.tamu.edu

Local fire departments are the first responders to wildland fires in Texas. However, when their capacity to control a fire is exceeded, Texas Forest Service (TFS) provides suppression assistance. TFS provides valuable support to our area through a cost sharing grant program that allows our Department to obtain critical firefighter safety equipment, tools, and training support at a reduced cost. This TFS grant program multiplies your donation dollars through a qualifying application approval process. For instance, we recently received over \$3,000 in cost share grants for training equipment, firefighter safety gear, and firefighting tools at a net cost of approximately \$600 from our local funds.

The Texas Forest Service also provides important public safety training, public service information pamphlets and community programs—all FREE. Our Department has teamed with their public information office to provide a series of pamphlets for our newsletter that meet seasonal needs in our area. The first one is enclosed:

"Safe Debris Burning: What do you have to lose?"

OUTDOOR FIRES ON PRIVATE PROPERTY

Many local residents and landowners routinely dispose of trash and debris by burning. When doing so, please obey any current fire "burn ban" warnings, and follow the safety procedures outlined in the enclosed brochure. When managing any visible fires, our Department also requests that you notify the Fayette County Sheriff's dispatcher at 979-968-5856, so that any calls received by them can be verified with you to avoid unnecessary fire department responses.
